WE REFER CLIENTS TO LEGAL ASSISTANCE, ADVOCATE TO PREVENT SOURCE OF INCOME DISCRIMINATION AND SUPPORT VOUCHER-BASED HOUSING PLACEMENT. LIKEWISE, WE OFFER COMPREHENSIVE BENEFITS ANALYSIS AND CONNECT CLIENTS TO INCOME SUPPORT SERVICES THROUGH GOVERNMENT AND COMMUNITY PARTNERS. FOR THOSE WHO NEED IT, WE PARTNER WITH LOCAL SOUP KITCHENS/FOOD PANTRIES AND FEMA TO OFFER EMERGENCY FOOD SUPPORT. IN FY'20, 8,000 NEW YORKERS RECEIVED HOUSING AND EMERGENCY SERVICES TO STAVE OFF EVICTIONS AND SECURE THEIR EXISTING HOMES, AND 35,000 MEALS
